#### Requirements and Expectations for Contestants and Titleholders

Contestants must self identify as a Male.

Contestants must live in the state of Texas.

Contestant will be expected to bring a basket/auction item to be auction off with proceeds benefiting the Mr. Texas Leather Travel Fund.

The contest winner must be willing to run for the title of International Mr. Leather.

The contest winner must provide to the producer all score sheets and notes from International Mr. Leather within 7 days of the end of the contest.

The contest winner must be willing to represent the State of Texas at bars, events, and state wide leather events.

The contest winner is strongly encouraged to attend other leather events and fundraisers.

The contest winner will be expected to take part in three fundraisers,

Two for the Mr. Texas Leather travel fund and

One for a local charity with in Texas. The charity will be a 501(c)(3) or 501(c)(7) not-for-profit charity and approved by the owners. In addition to the required fund raisers, the Winner is encouraged to use his title to help other community organization with fund raising efforts benefiting the GLBT and/or leather communities

The contest winner is expected to conduct himself as positive role models to the community and individuals who are/may consider competing in future leather contest. Flagrant violation of this expectation may result in the forfeiture of the title.

The contest winner may not compete in any other “leather” or “fantasy” contest during the year they hold the Mr. Texas Leather, other than IML.

The contest winner will be invited/expected to judge next year’s regional contest if he has fulfilled all of his obligations during the title year. Judging is not a guarantee.

The contest winner is expected to create, at his expense, business cards with his contact information, email address, and/or P O Box address within 30-days after the title was won.

#### Contestants will be judged in the following categories:

- Speech (100 points) – *Each contestant will each make a 2 minute (or less) speech during the Saturday evening contest on the topic of their choice.*
- Interview with Judges (150 points) – *During the Interview category, the judges will direct questions at contestants. The questions may address, among other topics, any aspect in general, BDSM, or leather history*
- Jock (150 points) – *During the Saturday evening contest, each contestant will be judged on physic and appearance while wearing a jock to show off their body. Jocks or T Backs used in this category must be Texas street legal.*
- Leather Image – *On stage question and answer (150 points) -- Each contestant will appear in their leather that best represents who they are and what they want to represent to the general public. At this time they will be ask a question and allowed 90 seconds to respond. The response to the question is not judged.*

**Scoring system:** The Olympic scoring system will be used.

**FRATERNIZATION WITH JUDGES**

All contestants shall be prohibited from having private meetings or engaging in sexual activity or leather scene play with the judges prior to the announcement of the results of the contest. Any behavior that would or suggest the appearance of bias will be brought to the attention of the head judge, who will decide if the disqualification of the judge and/or contestant is warranted. The head judge is required to address the disqualification with the owner(s) of the contest that will make the final decision. The decision to disqualify a judge and/or contestant based on grounds of fraternization is final.

To avoid accidental violation of this policy, all contestants and judges shall display their identification badges at all contest events.
